The monetary of financial assistance offered under the scheme is mentioned at Annexure I available on our website as accompanying notification document.

The candidate is required to get admission and registration for regular and full time M.Phil./Ph.D. course in a Government/University college recognised by UGC at the first available opportunity but not later than three months from the date of issue of this award letter. The candidate/Institute/Collage is required to provide for award of JRF based on the criteria, in accordance with the procedure available on our website.

It may be noted that the following award shall be disbursed through Direct Bank to bank account of the candidate who fulfil all the criteria. UGC has developed a dedicated web portal (<http://www.ugc.ac.in>) for carrying out the procedure. The Government/University/Institute and the candidate shall be required to create their own user id and password with unique Email/ID card for all subject have selected from provided website along with the password. The Government/University/Institute shall update the information in the master data (regarding master) system under master MCA registration requirement etc. in the Government/University/Institute based on the data updated on UGC web portal by the candidate/University/Institute/Institute, the progress of the award will be made in the Government/University/Institute process available at <http://www.ugc.ac.in> under www.ugc.ac.in 2021/2022.

It may also be noted that UGC had proposed to the "MORNING" with bank account of Institute in that there can be direct credit transfer and effective disbursement of fellowship into bank account of the candidate in that regard. However, UGC had requested the Government/University/Institute to disburse award under D.D. No. 1111/2021/2022 (PP) instead of 1111/2021.

It may please be noted that the award will be made to the candidate by implementing the award process and it will also direct legal action against the Institute in the following cases:

- i. If the candidate is found to be ineligible to receive the award at any point during the course duration of fellowship.
- ii. Misconduct of candidate.
- iii. Disruption into progress of research work.
- iv. Failure to get commensurate award in M.Phil./Ph.D.
- v. It is any other following to award procedure available on the Government/Institute.
